1716, November 15 - Joseph was twenty-three when his ear mark was recorded. Since it was the same as older brother Samuel's, it probably meant they were working the Munger farm in Guilford, together at this time. "...his Ear Mark is a Crop on the Near Ear and two Slits [] the Crop and a hole in the Same Ear which was the Mark of Samll Munger Junr" ®Guilford, Town Clerk. 1733/4, January 22 - Joseph was forty-one years old, married to his second wife, and had a family of five boys when his first wife's father, Samuel Ingham, died. In his will, Ingham left Joseph 20 Shillings and left Joseph's fifteen year old son, Samuel, by Ingham's daughter, Meriam, his (Ingham's) right in the undivided land in Pataguonik, and the remaining part of his estate not already disposed. @Connecticut, Wills and Probate Records, 1609-1999. 1749, November 21 - Joseph bought 22.5 acres in Salisbury, Litchfield County, CT from Caleb Woodworth. Joseph was late of Guilford, now of Salisbury, meaning that Joseph and family had moved to Salisbury by the end of 1749. The 22.5 acres was located at the south end of a piece of land that Caleb Woodworth had bought from Thomas Newcomb on the NY Colony line (rec. 8 May 1750). This 1749 land purchase by Joseph was referenced in a 1754 deed recorded by Garshom Woodworth, son of Caleb Woodworth, as the south end of a tract adjacent to a 30 acre gift from his father at the north end of a piece laid out to Thomas Newcomb on the New York line. ®Russell, Donna Valley. 1756 - Joseph, age sixty-three, was the only Munger on the list of taxpayers for Salisbury, CT. His tax was £35.0.0. ®Russell, Donna Valley. Salisbury, Connecticut, Records, Vol.2, p. 123; Archive.org

1760, Dec 8 - Joseph sold 55 acres of land in Salisbury, CT near Indian Mountain to Murray Lester of Pokepsie for £103.13. 1760 - Joseph was a Salisbury, CT taxpayer of £27.0.0. Joseph's son's Abner £22.0.0, Billy £52.12.0, and Increase £18.0.0 were also on the 1760 tax list as was Levi Munger, probably Joseph's nephew, son of brother James £32.0.0. ®Russell, Donna Valley.
